Age requirements: Minimum age to take examination is 20 years; 21 years to be appointed Education: HS diploma, HS transcript w/graduation date, or G.E.D.; submit copy of one with application Other: All sworn law enforcement personnel must be USA citizens, and must pass the APOSTC fitness test (requirements available in LEPB office or online), background investigation, interviews, polygraph, personality inventory, doctor's physical, and drug screen prior to appointment; applicants shall be required to meet State Minimum Standards for Law Enforcement Officers, and be able to complete State standard minimum training requirements after initial hiring; NO children or pets allowed at written or physical testing Examination Subjects and Weights: Ability to follow oral and written instructions; ability to read and comprehend written material; logical reasoning; memory and observation; Passing score: 70
